NORTHAM YOUTH WELLBEING PLAN

2018-2020

Long-term Outcome:

To reduce the harms associated with alcohol and other drug misuse and anti-social behaviour for young people; improving their mental health and wellbeing through the enhancement of connections with education, support services and activities.

PURPOSE

The Northam Youth Wellbeing Plan seeks to address the harms associated with alcohol and other drug use, build resilience and improve wellbeing to reduce the incidence of risky behaviours of young people within the community through:

- Actively supporting partnerships between community and service providers to identify and address local issues.
- Provide a means to coordinate, implement and evaluate an evidence-based, whole of community approach in a timely and appropriate manner.

BACKGROUND

The Plan was developed using best practice principles (see appendix 1).

The analysis of several consultation documents and reports dating from 2017-2018 and three Northam Shire Alcohol and Other Drug Management Plan review workshops involving the Western Australian Mental Health Commission and key Northam Shire stakeholders (February, March and May 2018) have provided the context for the YWP. These documents reflect the collective knowledge and experience of the Northam Shire AODMP planning workshops and should be consulted if further development of the YWP is required. 
WORKING DOCUMENT

Priority: Alcohol and other Drug use by young people, and associated disengagement from education, services and youth activities



BACKGROUND BEHIND YOUTH PRIORITY FOCUS

Throughout the review process of the Northam Shire Alcohol and Other Drug Management Plan 2015-2017, it was evident that participating agencies had a strong youth focus. Discussions during these workshops, further informed by the results of the Northam Community Perception Survey 2018, highlighted that the issues/problems experienced by the Northam community spanned further than those specifically as a results of AOD use/misuse; improvement was required with positive early life and behaviour changes with young people. Primarily the group decided to focus on improving provision of AOD intervention, education and prevention activities to reduce associated harms with young people in the Shire of Northam. The Northam Community Perception Survey 2018 highlighted that mental health and wellbeing was an identified key concern, thus it was decided by the committee that suicide prevention, mental health and wellbeing strategies would be incorporated into the plan also.

Primary Target: Young people aged 10 - 25 & service providers Secondary Target: Parents and Carers, whole of community

Short Term Outcomes:

- 1. Services/Agencies in the Shire of Northam are aware of the barriers and are working collaboratively to improve engagement with young people.
- 2. Community is more aware of the impact and harms caused by alcohol and other drug use
- 3. Young people are more engaged with education, youth activities and appropriate services for both AOD and Mental Health
- 4. Reduce risks for young people through and the provision of education and training, for youth, professionals and the broader community


APPENDIX 1

PLANNING FOR AN EFFECTIVE PLAN

Creating a sustainable reduction in alcohol and other drug related harm is a complex and long-term process. Issues can be overwhelming and seen as too difficult to address at a local level. However, with some effective planning, it's at the local level where partnerships between communities and services can have the greatest impact.

Prior to establishing and implementing an Community Wellbeing Plan (CWP), a number of steps need to happen to ensure the resulting plan has been developed in partnership to reflect the communities needs and has the best chance at creating sustainable change.

It is important that the community have a strong understanding of the issues and have ownership of the strategies developed to address them. To ensure this, processes should be put in place that allow community input into all stages of the development and implementation of the CWP, including progress made against addressing the issues.
